

**CARROLLTON TOWNSHIP  
SAGINAW COUNTY, MICHIGAN**

**PROPOSED ORDINANCE NO. 2018-01**

The Board of Trustees of Carrollton Township, Saginaw County, Michigan ordains that the Carrollton Township Code of Ordinances be amended as follows:

**SECTION I: PURPOSE.**

CHAPTER 42, SOLID WASTE, ARTICLE II. COLLECTION AND DISPOSAL, DIVISION 1, AMENDING SEC. 42-20 AND DIVISION 2, SEC. 42-57 AND 42-58 OF THE CARROLLTON TOWNSHIP CODE OF ORDINANCES is hereby created to read as follows:

**Sec. 42-20. – Authority of township or contract hauler.**

(d) Quantities, pick-up schedules, containers and points of collection shall be consistent with vendor contracts held by the **Mid Michigan Waste Authority (MMWA)**.

**Sec. 42-57. – Containers.**

(c) Capacity. Containers shall have a capacity of not more than **35 gallons** and 50 pounds and shall be of a kind suitable for collection purposes and shall be of such weight that they can be handled by one person.

**Sec. 42-58. – Storage.**

**(f) *Storage prior to collection.* All trash cans, waste material, debris, refuse, recycling, yard waste, garbage bags, or garbage shall be kept in a place not readily noticeable. Storage shall be away from places occupied by other persons. Any type of container capable of storing the items specifically listed above shall be reasonably hidden from a citizen's view from the road. Citizens shall take reasonable precautions while storing the above listed items so they cannot be easily disturbed by animals. Other than the time allotted by ordinance for collection; none of the above listed items shall be stored in the front of any residence.**

**SECTION II: REPEAL AND SAVINGS CLAUSE**

All other ordinances or parts of ordinances inconsistent or in conflict herewith are hereby repealed.

**SECTION III: PUBLICATION**

This Ordinance shall be published in a newspaper circulated within the Township of

Carrollton within ten (10) days following the adoption thereof.

**SECTION IV: EFFECTIVE DATE**

This Ordinance shall take effect thirty (30) days after publication.
